## **About Mahindra World City**

Mahindra World City is a PPP between the Mahindra Group and TIDCO (a Govt. of Tamil Nadu undertaking).

Conceptualized as an integrated business city, Mahindra World City has attracted around 60 best-in-class companies from across the world including BMW, B Braun, Capgemini, Infosys, Fujitec, Lincoln Electric, Mecaplast, NTN Corporation, Parker Hannifin, TVS Group of companies and Wipro. The business zone has 35 companies that are operational with the balance under various stages of construction/commencement of operations. The city has a current working population of 25,000 and is expected to reach 100,000 in the next 8-10 years. The exports from the 3 sector specific SEZs was Rs.3,500 crores in FY 2011.

The Residential Zone is master planned in close proximity to the Business Zone with varied social amenities built into the master plan comprising residential units, schools, medical centers, retail malls, a business hotel, recreation and leisure facilities etc. The residential development which started with Sylvan County (212 homes spread across 22 acres), currently has two offerings, namely, Aqualily (761 homes over 56 acres and Iris Court (702 apartments over 18 acres), both of which are currently under development and when completed will add an additional 1,500 homes to the city. The balance residential development is expected to be completed over the next 8-10 years.

Mahindra World City has a CBSE school, Mahindra World School, managed by the Mahindra World School Education Trust and currently has around 400 children. There is also a day care center from Amelio for infants and toddlers.

Mahindra World City also houses a commercial complex that provides for various everyday basic needs such as Banks/ATM, food court, restaurants, medical centre, department store etc.

MWCDL recently signed up Duet Hotels to bring in a Holiday Inn Express that will be set up as a 4-star business hotel and is expected to be operational by Sep 2013.

The next phase of development will include malls, multiplexes, a hospital, clubs with sports facilities, accommodation for single working professionals etc.

Mahindra World City, as part of its approach to holistic development has involved itself, with the support of NGOs, in skill up-gradation and employability training, training over 1500 village youth.
