JCB India to set up a manufacturing plant within MWC, Jaipur

Jaipur, October, 23, 2012: Mahindra World City (MWC), Jaipur, an Integrated Business City reaches another milestone with the signing of an agreement with JCB India, the global leader in construction equipment, to set up a manufacturing plant in 70 acres within Mahindra World City, Jaipur. The total investment for this new manufacturing facility, which will be JCB's fourth factory in India, will be to the tune of INR 500 crores.
