In the above reference, Environmental Clearance has been given for our project Mahindra World City Part II covering an extent of 212.295 acres.

The EC approval mentions certain conditions that have to be complied with.

Under Construction phase, the following conditions have to be complied with:-

i)	'Consent for Establishment' shall be obtained by the Proponent for its industrial park and also by its member industries from TNPCB and a copy shall be submitted to SEIAA, TN before taking up any construction activity at site.	We have applied to Chairman, TNPCB for Consent to Establish on 8th Aug'13 and the proposal is under process in the HO of TNPCB.
iii)	The Developer shall obtain necessary permission from the GoTN for utilizing the excess water drawal from the Kolavai lake available with MWC Part I prior to commencement of any civil work in the proposed industrial estate project phase II.	We have applied to PWD for permission to use 2.00 mgd of water for the existing project and the new projects. Proposal is pending with the Engineer-in-Chief, WRO, PWD.
v)	The Developer shall obtain required permission from the District Forest Officer / Wild Life Warden of the Reserve Forest as reported in the project report before commencement of the work.	Permission got from Wildlife Warden and informed to SEIAA vide our letter dt.30.11.2013.
x)	For disinfection of waste-water system using ultra violet radiation shall be adopted.	Tender finalised and Work Order issued to the Contractor. Report will be sent after UV system is installed.
xix)	Low Sulphur Diesel shall be used for the diesel generator sets to be used during construction phase. The air and noise emission shall conform to the standards prescribed in the Rules under the Environment (Protection) Act, 1986 and the Rules framed thereon.	This will be complied with during construction phase after Consent to Establish order is received.
xx)	Vehicles hired for bringing construction materials to the site should be in good condition and should conform to air and noise emission standards, prescribed by TNPCB/CPCB. The vehicles should be operated only during non-peak hours.	Contractor will be informed when the project reaches construction phase.

xxi)	Ambient air and noise levels should conform to residential standards prescribed by TNPCB, both during day and night. Incremental pollution loads on the ambient air and noise quality should be closely monitored during the construction phase.	Air and noise level monitoring will be done after the project reaches construction phase.
xxxiv)	All Energy Conservation Building Code (ECBC) norms shall be adopted.	This does not apply as only infrastructure works are being done by the Developer

Half yearly compliance has been sent vide our letter dt. 30th Nov'13.
v)	The Project proponent shall advertise in atleast two local newspapers widely circulated in the region, one of which shall be in the vernacular language informing the public that i)The Project has been accorded Environmental Clearance. ii) Copies of clearance letters are available with the TNPCB. iii) Environmental Clearance may also be seen on the website of the SEIAA (www.seiaa.tn.gov.in) The advertisement shall be made within 7 days from the date of issue of the clearance letter and a copy of the same shall be forwarded to SEIAA-TN.	This has been complied with and informed vide our letter dt. 30 th Nov'13.
vii)	The proponent shall upload the status of compliance of the stipulated EC conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MoEF, Bengaluru the respective zonal office of CPCB, Bengaluru and the TNPCB. The criteria pollutant levels namely, SPM, RSPM, SO2, NOX (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the project shall be monitored and displayed at a convenient location near the main gate of the company in the public domain.	Status of compliance of stipulated EC condition is updated as on 31.03.2014 and the same is sent. The status of compliance has been uploaded in our website.
viii)	A copy of the clearance letter shall be sent by the proponent to the Block Development Officer and the Local NOG, if any, from whom suggestions / representations, if any, have been received while processing the proposal. The clearance letter shall also be put on the website of the proponent.	Clearance letter has been sent to BDO, Kattankulathur on 28th Oct'13. Clearance letter has been put up on MWCDL website also. This fact has already been indicated vide

		our letter dt. 30 th Nov'13.
xiv)	The project proponent shall submit six-monthly reports on the status of compliance of the stipulated environmental clearance conditions including results of monitored data (both in hard copies as well as by e-mail) to the Ministry of Environment and Forests, its Regional Office, Bangalore the respective Zonal Office of Central Pollution Control Board, SEIAA, TN and the State Pollution Control Board.	1st report has been sent on 1st Dec'13 vide our letter dt. 30 th Nov'13.
xv)	The environmental statement for each financial year ending 31st March I Form-V as is mandated to be submitted by the project proponent to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be put on the website of the company along with the status of compliance of environmental clearance conditions and shall also be sent to the Regional office of the Ministry of Environment and Forests, Bangalore by e-mail.	Consent to Establish order is awaited from TNPCB and hence the project has not reached the construction stage. Environmental statement ending 31st March'14 is not sent.
